**Resolution 2009-44**

**A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF LA PLATA COUNTY, COLORADO, SETTING FORTH FEES TO BE CHARGED FOR SERVICES RELATED TO ISSUANCE OF LIQUOR LICENSES AND PERMITS, AND AMENDING RESOLUTION 1997-40.**

**WHEREAS**, the Board of County Commissioners of La Plata County, as a local licensing authority under the Colorado Liquor Code and the Colorado Beer Code, is authorized by C.R.S. §§ 12-47-505, 12-46-107, and 12-48-104 to charge certain fees for licenses and permits issued by the local licensing authority; and

**WHEREAS**, liquor license and permit fees are listed in the fee schedule provided in Appendix A of the County Code; and

**WHEREAS**, La Plata County last increased or otherwise modified liquor license and permit fees under Resolution 1997-40, on June 23, 1997; and

**WHEREAS**, Colorado Senate Bill 07-149, adopted April 20, 2007, amended C.R.S §12-47-505(4)(a) to provide for an increase, on a tier basis, in the amount of fees local jurisdictions are permitted to charge for alcohol beverage related license or permit applications; and

**WHEREAS**, Colorado House Bill 08-1105, adopted May 28, 2008, amended C.R.S § 12-47-505(1)(a) and (4)(a) to add a new permit for art galleries and provide fees local jurisdictions are permitted to charge for such permits; and

**WHEREAS**, an analysis of the costs incurred by La Plata County to process new license applications, transfer and renewal applications, as well as Special Events permits, prepared by the Administrative Assistant to the Board of County Commissioners, illustrates that under the present fee schedule, costs incurred by the County to process and approve such applications exceeds the revenues generated by almost \$6000, and if the proposed fee increases are approved, costs will exceed revenues by approximately \$3000; and

**WHEREAS**, the Board of County Commissioners of La Plata County, as the local licensing authority, determined that it is both necessary and appropriate that the license and permit fees be increased to help cover actual and necessary expenses;

**NOW, THEREFORE, BE IT RESOLVED** that:

- A. The Board of County Commissioners of La Plata County, as the local licensing authority hereby amends the liquor license and permit fees schedule

provided in Appendix A of the La Plata County Code by adopting the following application fees:

1. For a New license, after July 2, 2010, One Thousand Dollars;
2. For a Transfer of Location or Ownership after April 1, 2010, Seven Hundred and Fifty Dollars;
3. For a Renewal of License after April 1, 2010, One Hundred Dollars;
4. For a Special Events Permit (3.2%) the fee after April 1, 2010, shall be One Hundred Dollars per event.
5. For a Special Events Permit (Liquor) the fee after April 1, 2010, shall be One Hundred Dollars per event.
6. For a new license or renewal of an art gallery permit the fee shall be One Hundred Dollars.

B. The Board of County Commissioners of La Plata County, as the local licensing authority hereby amends the liquor license and permit fees schedule provided in Appendix A of the La Plata County Code by adopting the following permit fees:

1. For an art gallery permit, the fee shall be Twenty-Five Dollars.
2. For a resort-complex-related permit, the fee shall be One Hundred Dollars.


C. The Board of County Commissioners of La Plata County, as the local licensing authority hereby amends the liquor license and permit fees schedule provided in Appendix A of the La Plata County Code by adopting the following license fees:

1. For a beer and wine license issued to a resort hotel, the fee shall be Fifty-Six Dollars and Twenty-Five Cents.
2. For a retail gaming tavern license, the fee shall be Seventy-Five Dollars.

D. All other fees provided in the liquor license and permit fees schedule of Appendix A of the La Plata County Code shall remain unchanged.


