RESOLUTION NO. 2006-24

**A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS
OF LA PLATA COUNTY, COLORADO, DESIGNATING THE
MCDONALD RANCH BARN SITE TO THE COUNTY HISTORIC
REGISTER**

WHEREAS, § 30-11-107 (bb) of the Colorado Revised Statutes empowers the Board of County Commissioners to provide for the preservation of cultural, historic, and architectural history within the County; and

WHEREAS, based upon the evidence and testimony presented at a public hearing on November 15, 2004, the Board of County Commissioners of La Plata County found it desirable to create a Historic Preservation Review Commission to establish a procedure for designation of local historic districts and landmarks; and

WHEREAS, the Board of County Commissioners enacted Resolution 2004-33 to establish a procedure for the designation of appropriate historic sites and historic landmarks or historic districts, recognizing such designations to be an integral part of the preservation of cultural, historic and architectural history within the County; and

WHEREAS, the Board of County Commissioners appointed a three-member Historic Preservation Review Commission; and

WHEREAS, the Historic Preservation Review Commission has reviewed the site, project 2006-0146, and found this site to be of historical significance to La Plata County and has presented to the Board of County Commissioners a recommendation for inclusion of this site on the County Historic Register; and

WHEREAS, the La Plata County Board of County Commissioners held a duly noticed public hearing on the 27th day of June, 2006, to consider whether the Board of County Commissioners should accept the recommendations of the Historic Preservation Review Commission; and

WHEREAS, based upon the evidence presented at the hearing and the recommendation of the Historic Preservation Review Commission, the La Plata County Board of County Commissioners approves the McDonald Ranch Barn Site, project 2006-0146, for inclusion on the La Plata County Historic Register;

**NOW THEREFORE, BASED UPON THE EVIDENCE AND TESTIMONY
PRESENTED AT THE PUBLIC HEARING CONDUCTED THIS 27th DAY OF JUNE
2006, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF LA
PLATA COUNTY, COLORADO, AS FOLLOWS:**
