RESOLUTION NO. 2006-36

**A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS
OF LA PLATA COUNTY, COLORADO, DESIGNATING THE OLD
FT. LEWIS CAMPUS, TO THE COUNTY HISTORIC REGISTER**

WHEREAS, § 30-11-107 (bb), of the Colorado Revised Statutes empowers the Board of County Commissioners to provide for the preservation of cultural, historic, and architectural history within the County; and

WHEREAS, based upon the evidence and testimony presented at a public hearing on Nov. 15, 2004, the Board of County Commissioners of La Plata County found it desirable to create a Historic Preservation Review Commission, to establish a procedure for Designation of Local Historic Districts and Landmarks; and

WHEREAS, the Board of County Commissioners enacted Resolution 2004-33 to establish a procedure for the designation of appropriate historic sites and Historic Landmarks or Historic Districts, recognizing such designations to be an integral part of the preservation of cultural, historic and architectural history within the County; and

WHEREAS, the Board of County Commissioners appointed a three member Historic Preservation Review Commission; and

WHEREAS, the Historic Preservation Review Commission has reviewed the Old Ft. Lewis Campus nomination, project 2006-0312, and found this site to be of Historical significance to La Plata County and accordingly, the Historic Preservation Review Commission has presented to the Board of County Commissioners, its recommendation for inclusion of this site on the County Historic Register; and

WHEREAS, the La Plata County Board of County Commissioners held a duly noticed public hearing on the 19th day of September, 2006, to consider whether the Board of County Commissioners should accept the recommendations of the Historic Preservation Review Commission; and

NOW THEREFORE, BASED UPON THE RECOMMENDATION OF THE HISTORIC REVIEW COMMISSION, EVIDENCE AND TESTIMONY PRESENTED AT THE PUBLIC HEARING CONDUCTED THIS 19 DAY OF SEPTEMBER 2006, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF LA PLATA COUNTY, COLORADO, AS FOLLOWS:

1. That the Old Ft. Lewis Campus project 2006-0312 is hereby approved for inclusion on the La Plata County Historic Register. Location is approximately 247 acres, a portion of Parcel No. 5659-023-00-015, located at 18683 Hwy 142, Hesperus CO., Section 2, Township 34N, Range 11W, and further described in the attached exhibit A.




